# Progress & Achieving in this year 2021-2022.

## Dalit & Tribal women empowerment

EPT promote the leadership capacity building of Dalit and tribal women through the training , workshop , exposure and knowledge searing with community this time EPT organized the training of leadership development of Sabar women, legal training, provide

information about the govt, schemes and programs



This program for achieving their active participation and access of the govt. facilities. Empowerment of women power. EPT preparation and distribution of ICE material, in local language. Setup village level information centre in 32 village, and provide a box in every village and every information about MGNREGA, FRA, PRI, Women development, Govt. schemes, ST/SC (Poa) .RTI ,etc. Organized an information user committee in village level for proper utilization information for needs of the peoples.



#### Girl Child Education Programme

EPT promote the education of the girl child and women. In village level practice the signature of every woman to reduce the simple of thumps. Provide Training the educated youth about the process of learning through the language of sabar to odiya and continue the education center in village level and enrolled to children in govt. school. Continue a girl child education promotion centre in Banpur is for higher education of girl child because after the 7<sup>th</sup> class all girls are dropout from the school. Because there are no high school in this area. High school is 25 to 30 Km distance from the area so the parents are not interested to continue girls education. So EPT provide accommodation of home and motivate the parents for higher education for girl and promote a hostel facilities and security for girls and enrolment the high school and college for high education for girls.



## Sustainable livelihood promotion

EPT organized the activities of land and forest based livelihood training, and facilitates the proper implementation of govt. livelihood and food security program (MGNREGA) by the active participation of village community. This program empowered to the group of farmer, women, and laborers to access their livelihood rights and food security. Ept support for kitchen garden of 1690 families of Khurda, Ganjam, and kalahandi district 32 villages.

Ept promote the micro land livelihood campaign program through the women and youth group. Educate to the village peoples about the organic seed protection and food production and eco environmental livelihood process. Plantation of fruit bearing trees and kitchen garden programs for promotion of food and nutrition.





#### Self-governance

Ept awareness on strengthening the self governance system in village level ept educate and encouraged the peoples to participate in Gramshava and Palli Sabha, and strengthen the Panchayatiraj system .EPT promote the women participation in this system and take leadership and decision making for village development.

#### Protection of Tribal Culture

EPT promote and strengthening the tribal and Dalit cultural system in village level and promote the cultural group for saves the traditional culture and art.

#### Observation of National Day

Ept organized the convention of women and village youth for observation the National Day of Independence Day, Republic Day, Constitution day, Women's Day etc.



## Social security and protection

EPT continue awareness and link with the social security scheme of child women and older person who have totally ignore by the society and also continue the awareness program in community for social security rights of the child women and older person and counseling of the family and organized the workshop for support of legal information about the child women and old age safety protection and help. EPT also support for legal rights of child and women.

## Health Education Program

The Malaria, TB, dairies etc. diseases are major problem of the target area we have undertaken a number of health education initiative as well as more practical assistance ept also support to access the benefits of health insurance through smart card.





## Youth capacity building

EPT organized the program for youth volunteers capacity building about people's communication, group management, gender justice, constitutional rights and role, women develop and promote the strength of human resource. And provide scope for access the multiple training of capacity and leadership development of the youth staff. This effort improved the women participation and decision making, collective work process & knowledge about work.



#### Forest & environment protection

Ekta parishad trust organized the awareness program for forest and environment protection through the village committee. After the forest rights act. Village forest rights committee was take responsible their nearest village forest protection and every year Ept organized plantation program through the youth, school children, and women group EPT organized the training about forest and bio-diversity. Protection in the effort of EPT peoples of 109 villages protects the 2500 hector forest and bio-diversity.



## Women & youth skill development

EPT organized Skills training for 150 dropout youth for improve the skill labour Ept support and identify the youth of dropouts and organized the various skills straining like cane and Bamboo craft, redimed concrete items, cell phone, and TV repairing, NTFP processing skills, tailoring, leaf plats stitching, mate making and other cottage craft item. Ept also organized skill training for 169 women from 42 villages.
